The City of Coconut Creek is an entitlement recipient of federal funds from the U.S. Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG) Program. The City has prepared amendments to the Program Year 2014 and Program Year 2015 Action Plans to re-allocate funding to programmed activities. The proposed amendments, summarized below, will support the goals and objectives of the City's five (5) year Consolidated Plan and will primarily benefit low-to-moderate income residents of the City of Coconut Creek. No displacement or relocation of Coconut Creek residents or businesses is anticipated.
