### Pertaining to Landscape/Tree Removal Permit Application Procedures

To expedite your permit and to protect you as a property owner, submit the following with your completed, signed and notarized permit application:

- 1**
  - Photocopy of your property survey – show the location of tree(s) to be removed and proposed area for tree replacement
  - Letter of approval from Homeowners Association
  - Copy of Contractor's Occupational License & Certificate of Insurance – showing liability insurance, Workers Compensation
  - Owner/Builder Affidavit - if you are doing the work yourself

---

- 2** Upon receipt of the completed application a site visit will be performed by the City to determine whether or not the application shall be approved or denied. Application for a tree removal permit constitutes consent by the property owner and/or applicant for the city to conduct site inspections.

---

- 3** Upon approval of the tree removal permit, suitable replacement trees will be determined and listed on the application. You will be notified to pick up the permit at City Hall. Any required fees shall be paid at time of permit issuance, if applicable. Post the permit on your property in a visible location.

---

- 4** The owner or contractor must contact the City for a final inspection when the work is completed. Note: The inspection will determine if the replacement trees meet the size, species, and Florida Grade #1 standard. Proper staking, planting depth, watering and mulching techniques will also be inspected.

---

- 5** Notice: In addition to the requirements of this permit, there may be additional restrictions applicable to this property that may be found in the public records of this county, and there may be additional permits required from other governmental entities such as water management districts, state agencies or federal agencies.

---

- 6** The issuance of a Tree Removal Permit does not give you permission to violate deed restrictions and / or homeowners regulations. Please check deed restrictions before commencing any removals.

---

- 7** For the removal of more than 5 trees refer to the Land Development Code 13-448 (g).
